#### **Memorandum of Understanding**

This Memorandum of Understanding is entered into by and between the Spencerville Local School District Board of Education (Board) and the Spencerville Education Association (Association).

WHEREAS, the Board and Association have entered into a Collective Bargaining Agreement (CBA) which is effective from July 1, 2020 through June 30, 2021;

WHEREAS, given the uncertainties associated with safe and appropriate responses to the COVID-19 pandemic, the parties recognize that supplemental contracts may not be able to be performed completely or at all during the 2020-2021 school year;

WHEREAS, the CBA does not contemplate non-completion or partial completion of supplemental contract duties as a result of pandemics;

WHEREAS, the parties intend to amend their current CBA as set forth hereinafter, and further intend that all remaining sections of the CBA, that are not inconsistent herewith, shall remain in full force and effect:

NOW THEREFORE, IT IS HEREBY AGREED by and between the Board and the Association that the following shall constitute their Agreement as it relates to this matter:

- 1. The Board will continue to compensate supplemental contract employees in accordance Article IX(D) and Article XII unless the contract is not fully performed as a result of COVID-19.
- 2. With regard to athletic supplemental contracts, the Board will provide partial compensation, on the following pro-rated basis, if supplemental contract employees do not fully perform their supplemental contract(s) as a result of COVID-19:

Preseason completed = 1/3 total compensation At least 50% of season completed = 2/3 total compensation

The percentage of the season that is completed shall be determined by the administrator, along with the holder(s) of the supplemental athletic supplemental contract. The administrator shall make the final determination.

- 3. All other provisions of the CBA, shall remain in full force and effect except as modified by this Memorandum of Understanding.
- 4. This Memorandum of Understanding shall remain in effect for the 2020-2021 school year and shall not continue in effect beyond June 30, 2021 unless expressly agreed to by the parties.

WHEREAS, pursuant to the provisions of Section 5705.21 of the Ohio Revised Code, this board has determined the necessity to levy a tax in excess of such ten-mill limitation for the purpose of providing funds for permanent improvements at the rate not exceeding one and four-tenths (1.4) mills for each one dollar (\$1.00) of valuation for a period of five (5) years; and

WHEREAS, the County Auditor has certified the total current tax valuation of Spencerville Local School District and the dollar amount of revenue that would be generated by the proposed levy annually.

BE IT RESOLVED by the Board of Education of the Spencerville Local School District (herein the "School District"), Counties of Allen, Auglaize and Van Wert, Ohio, two-thirds of all the members elected thereto concurring:

SECTION 1. That the board of education hereby determines to proceed with the renewal levy and the question of the adoption of said tax shall be submitted to the electors of the entire territory of the School District at the election to be held on November 3, 2020, and if said tax is approved by a majority of said electors such tax levy shall first be placed upon the 2021 tax list and duplicate, for first collection in calendar year 2022.

SECTION 2. That the form of the ballot to be used at said election shall be substantially as follows:

#### PROPOSED TAX LEVY SPENCERVILLE LOCAL SCHOOL DISTRICT A majority affirmative vote is necessary for passage

A renewal of a tax for the benefit of the Spencerville Local School District FOR THE PURPOSE OF PROVIDING FUNDS FOR PERMANENT **IMPROVEMENTS** at a rate not exceeding one and four-tenths (1.4) mills for each one dollar (\$1.00) of valuation, which amounts to fourteen cents (\$0.14) for each one hundred dollars (\$100.00) of valuation, for a period of five (5) years, commencing in 2021, first due in calendar year 2022.
